

ORDINANCE No. 2019-4

ORDINANCE LEVYING AND ASSESSING MUNICIPAL TAX FOR LILLIE M. EVANS

LIBRARY DISTRICT OF THE COUNTIES OF PEORIA AND MARSHALL, STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING THE FIRST DAY OF JULY, 2018, AND ENDING THE 30TH DAY OF JUNE, 2019.

WHEREAS, the President and Board of Trustees of the Lillie M. Evans Library District, in the counties of Peoria and Marshall and State of Illinois, did on the 13th of September, 2018, pass the Annual Budget and Appropriation Ordinance (Ordinance No. 2019 -3) for said Library District for the fiscal year commencing on July 1, 2018 and ending June 30, 2019; and

WHEREAS, the Annual Budget and Appropriation Ordinance was duly published as provided by law after its passage;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE LILLIE M. EVANS LIBRARY DISTRICT, IN THE COUNTIES OF PEORIA AND MARSHALL AND STATE OF ILLINOIS, as follows:

Section 1: That the total sum of THREE HUNDRED SEVENTY-SEVEN THOUSAND EIGHT HUNDRED DOLLARS (\$377,800.00) composed as follows: The sum of TWO HUNDRED EIGHTY-FOUR THOUSAND NINE HUNDRED DOLLARS (\$284,900.00), being the amount deemed required for the necessary corporate purposes of Lillie M. Evans Library District, Peoria and Marshall Counties, Illinois; the sum of SIXTEEN THOUSAND DOLLARS (\$16,000.00), being required for the payment of employer contributions of Lillie M. Evans Library District to

the Social Security Fund; the sum of THIRTY THOUSAND DOLLARS (\$30,000.00), being required for the payment of employer contributions of the Lillie M. Evans Library District to the Illinois Municipal Retirement Fund; the sum of TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00), being required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund; the sum of TWENTY-FOUR THOUSAND TWO HUNDRED DOLLARS (\$24,200.00), for the purpose of payments of premiums due for the purchase of liability insurance, property damage (fire) insurance and legal fees for defending or otherwise protecting itself against liability from a Liability Fund; the sum of ONE THOUSAND THREE HUNDRED DOLLARS (\$1,300.00), for the sole purpose of Worker's Compensation Insurance; the sum of EIGHTEEN THOUSAND NINE HUNDRED DOLLARS (\$18,900.00), being required for the maintenance, repairs and alterations of library buildings and equipment from a Maintenance Fund, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2018 and ending June 30, 2019 and the Board of Trustees of the Lillie M. Evans Library District having been duly published in a newspaper of general circulation within this Library District, this Board finds that the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Lillie M. Evans Library District.

Section 2: The Secretary of the Board of Trustees of the Lillie M. Evans Library District is hereby directed to file a duly certified copy of this ordinance with the County Clerks of Peoria

and Marshall Counties, Illinois, in accordance with the laws of the State of Illinois, on or before the third Tuesday of December, 2018, and said County Clerks are hereby authorized and directed to extend the said levy so levied by this Ordinance, according to the law, against all taxable property within the Lillie M. Evans Library District. The secretary of the Lillie M. Evans Library District shall also file on or before the third Tuesday of December, 2018, duly certified copies of the Annual Budget and Appropriations Ordinance and this Ordinance with the Lillie M. Evans Library where they shall be available for public inspection as provided by law.

Section 3: This ordinance shall be in full force and effect from and after its' passage and approval as provided by law.
